FAMILY BUSINESS SUCCESSION: IT TAKES KNOWLEDGE, SUPPORT, PLANNING, AND HEALTHY RELATIONSHIPS

Transferring the ownership or management of a company is one of the toughest processes in its life-cycle. In the case of **family enterprises**, the whole process is far more challenging, as more than often family businesses fail to pass the torch to the next generation either within or beyond the family. **Business dynamics and interests** are brought face-to-face with **family interests and relationships** among kin, in a mix that is really hard to deal with successfully. The viability of family firms on the other hand is of such great importance across the European Union, since they account for a very large part of employment and are substantially supporting national economies and the European economy as a whole.

Success...ion, an EU project funded by European Commission's Erasmus+ Programme, has been set-up to develop online guides and training provisions to enhance those skills and knowledge, much needed by family business owners as well as business advisors. Our aim is to stress the importance of timely transfer planning, and eventually facilitate successful family business transfers. We are looking mostly into the family-side of the succession process, as it mixes up however with business aspects, and what it really takes for all family members and beyond in terms of knowledge, support, planning and managing relationships to carry out this process. We also explore the role of the business advisors and how they could better deal with this demanding issue when they collaborate with family businesses.

During the project, **innovative training solutions**, freely available online will be created and namely:

- A succession guide for transferors and successors in family firms
- A family business transfer and succession guide for business consultants
